Changes to This Policy

Who We Are

Aroma Apothecary Healing Arts Academy INC., which includes employees, independent contractors, and director — collectively, "Aroma Apothecary Healing Arts Academy, "we," or "us") provide professional aromatherapy education and products. We are a Corporation based in Crestone, Colorado, USA. The founder and director of Aroma Apothecary Healing Arts Academy is Shanti Dechen.

How This Policy Applies

This Policy describes the information we collect from you, how we use that information and our legal basis for doing so. It also covers whether and how that information may be shared and your rights and choices regarding the information you provide to us.

By using the Services offered by Aroma Apothecary Healing Arts Academy INC., you are acknowledging you have agreed to our Terms of Use and that you have read and understood this Privacy Policy.

What We Collect and Receive

In order for you to enroll in courses or join our email list on https://www.learnaroma.com/ and use our Services, we need to collect and process certain information. Depending on your use of the Services, that may include:

Information you provide by completing forms on Aroma Apothecary Healing Arts Academy; when enrolling in a course, programs, other purchases, subscribe to our email list, or if you contact us. This information can include your legal name, postal address, telephone number, country of residence, and email address.

Details of any transactions that you make through the Services. Aroma Apothecary Healing Arts Academy partners with Authorize.net for payment processing, and the payment information you submit is collected and used by them in accordance with their secure privacy policies. Aroma Apothecary Healing Arts Academy does not have access or store any of your credit card information. Through Ecwid.com we do have access and store the enrollment information which includes the time, date, specific course enrollment or product purchased, your full name, postal address, telephone number, country of residence, email address and the amount of the purchase.

Information about your activity on and interaction with Aroma Apothecary Healing Arts Academy, (such as your IP address, the type of device or browser you use, and your actions on the Site);

Information about the ways people visit and interact with our Site, in the form of traffic analytics. You can opt out of being included in Google Analytics here. For more information about our use of data analytics to protect and improve our Services, see our Cookie Policy;

Communications you send to us (for example, when you ask for support, send us questions or comments, or report a problem);

The name and email address associated with your account. We will never post anything to your Facebook, Twitter, or other third-party accounts without your permission.

You may decline to provide us with your information. However, this will limit your ability to enroll in a course or use our Services. You may review, change, or remove your information by contacting us.

How We Use This Information

We use the information we collect for the following purposes:

To keep your account secure and protect our Services (including to verify the identities of creators and prevent fraud and abuse);

To enable us to provide you with our Services, and to improve and promote our Services;

To create and administer your account, contact you, and customize your experience on Aroma Apothecary Healing Arts Academy.

To track and analyze use of the Services so that we can improve how Aroma Apothecary Healing Arts Academy is performing and provide users with the best experience possible.

European Union Users

Data protection law in Europe requires a "lawful basis" for collecting and retaining personal information from citizens or residents of the European Economic Area. Our lawful bases include:

Information that's shared with trusted third-party services

When we share data with third-party services that support our delivery of the Aroma Apothecary Healing Arts Academy Services, we require that they use your information only for the purposes we've authorized, and that they protect your personal information at least to the same standards we do. We may also share information that's aggregated and anonymized in a way that it doesn't directly identify you.

Information that's shared to protect Aroma Apothecary Healing Arts Academy and comply with the law

We do reserve the right to disclose personal information when we believe that doing so is reasonably necessary to comply with the law or law enforcement, to prevent fraud or abuse, or to protect Aroma Apothecary Healing Arts Academy's legal rights, property, or the safety of Aroma Apothecary Healing Arts Academy, its employees, users, or others.

Links to other websites and services

Our Site may include links to other websites or services whose privacy practices may differ from Aroma Apothecary Healing Arts Academy's. When you use a link to an external site or service, the privacy policy and data processing disclosures for that site or service governs.

Retention

We will retain your information as long as your account is active, as necessary to provide you with the Services or as otherwise set forth in this Policy. We will also retain and use this information as necessary for the purposes set out in this Policy and to the extent necessary to comply with our legal obligations, resolve disputes, enforce our agreements and protect Aroma Apothecary Healing Arts Academy's legal rights.

We also collect and maintain aggregated, anonymized or *pseudonymized* (data management and de-identification procedure) information which we may retain indefinitely to protect the safety and security of our Site, improve our Services or comply with legal obligations.

Data Transfers

Because Aroma Apothecary Healing Arts Academy is a USA-based company, your information will be collected and processed in the United States. The United States has its own laws governing data protection and government access to information. The rules that protect your personal information under United States law may be different than in your home country. If you choose to use the Services, you need to agree to our Terms of Use, which set out the contract between Aroma Apothecary Healing Arts Academy and its users.

Your Rights

Users residing in certain countries, including the EU, are afforded certain rights regarding their personal information. Except where an exception or exemption applies, these rights include the ability to access, correct, and request deletion of your personal information. You may also elect to receive certain blog and marketing email communications, in accordance with your preferences, and from which you may opt out at any time by unsubscribing. We will also send you service-related announcements when it's necessary to do so.

Security

We take security seriously, and the security of your personal data is important to us. We follow industry-standard practices to protect the data we collect and maintain, including using Transport Layer Security (TLS) to encrypt information as it travels over the internet. No method of transmission over the internet or electronic storage is completely secure, so Aroma Apothecary Healing Arts Academy cannot guarantee its absolute security. Children

COOKIES

This policy explains our use of cookies and other technologies to understand, improve and protect Aroma Apothecary Healing Arts Academy.

What they are

Cookies are small data files that are issued to your device when you visit a website and that store information about your use of a service. Pixel tags (which are also called clear GIFs, web beacons, or pixels) are little snippets of code or tiny images embedded on websites and in email that help us learn how you interact with our site and emails.

Why we use them

Aroma Apothecary Healing Arts Academy uses cookies and these other technologies to help recognize you as a repeat visitor and, to improve the quality of our Services.

How they work

When you visit Aroma Apothecary Healing Arts Academy, our web server sends a cookie to your device, which allows us to recognize your device (but not the specific person using it). By associating the identification numbers in the cookies with other account information when, for example, you log in to our Services, we know that the cookie information relates to your user account. Similarly, pixel tags on Aroma Apothecary Healing Arts Academy and in email communications help us identify how your device is being used to interact with Aroma Apothecary Healing Arts Academy content. Some examples of the types of cookies and other technologies Aroma Apothecary Healing Arts Academy uses:

Authentication

Aroma Apothecary Healing Arts Academy uses authentication cookies and similar technologies to tell us when you're logged in to Aroma Apothecary Healing Arts Academy. This lets us show you personalized views related to your interests and connect you with projects like those you may already have backed.

Security

Cookies also help keep Aroma Apothecary Healing Arts Academy secure by facilitating security features and allowing us to detect activity that might violate our rules and Terms of Use. Analytics and research

Social Media Platforms
